Player may not lay club on the green to line up putt

If ball lodges between edge of hole and pin, it is deemed in if any part of ball is below edge.

There is no penalty if putted ball hits flag or another club laying on green if both have been properly placed and not purposely placed to stop ball. Care must be taken to place them out of the way.

Lost ball or out of bounds. Player incurs (2) stroke penalty and must play next ball as follows:

1. Determine where ball went OB or is likely lost
2. Find nearest fairway edge (no closer to hole)
3. Relief area is (2) club lengths either side of fairway edge.

### Rules remaining the same

A provisional ball is played when player anticipates a lost ball or an out of bounds ball. If original ball is found, player must play that ball.

Penalty area with regards to water hazard, (1) stroke penalty. Player has option of playing from original spot or drop Behind the water hazard on the line where the ball entered the water. May choose distance when moving backwards.

If stance or swing is affected, player may take relief without penalty, from casual water, ground under repair, cart paths, staked trees, sprinkler heads and drain covers. Relief is not allowed if the only impediment is line of sight.

Point of relief is nearest to where the ball lies, no closer to the pin and allows player a stance & swing plus (1) club length. When preparing to make a stroke, or player accidently causes the ball to move, there is no penalty. Replace the ball.

## New Golf Rules Effective 2019

Search time for lost ball is reduced **from 5 to 3 minutes**.

There is no penalty if player moves ball while looking for it.  
Just replace it.

Player may move an imbedded ball both on the fairway or in rough. Place it out of crevice.

Player's longest club, except for putter is deemed the appropriate Club for measuring distance when dropping a ball.

When dropping a ball, stand with straight legs and drop from knee height.

Player must take relief if ball lands on the wrong green.  
Do not stand on or hit ball from the putting surface.

There is no penalty to player for hitting himself or equipment and no penalty if player double hits the ball.

Player may remove rocks, twigs & leaves from sand, but if ball moves, it is a (1) stroke penalty. Player may not test the sand or ground club.

If ball is deemed unplayable in the bunker, player may move one club length backwards and take a (1) stroke penalty OR pull out behind the bunker for a (2) stroke penalty.

Player may ground club in the penalty area. (not in a bunker)

If ball accidentally moves on green, or player drops ball marker and causes the ball to move, or if someone else moves player's ball on the green, replace with no penalty.

Player may repair any imperfections on the green.
